Instructions for measuring and entering Fish into the NCBA "All Time Record List" and the "Annual Awards Contest"

1. The fish must be weighed on the most accurate scales available, to the nearest ounce. Potential state record fish must be weighed on certified scales.
2. The fish must be measured for "length" from the tip of the nose to the approximate center of the tail to the nearest 1/8 of an inch. Note the differences for each species of fish on the sketch.
3. The "Girth" of the fish shall be measured at the largest place in the approximate location shown on the sketch for each species to the nearest 1/8 of an inch.
4. Circle the name of the fish on the score sheet.
5. The entrant shall fill in, or provide all required information on the score sheet as required by the rules.
6. The witness to the weighing and measuring of the fish shall sign the score sheet, or provide a written affidavit attesting to the same.

Rules:

1. All entries must be weighed and measured for "length" and "girth".
2. A witness to the weigh-in must sign the score sheet.
3. The shooter must possess either a NC sportsman License, a Primitive Weapons License, or a Special Devices License. The type of license and the license number must be recorded on the score sheet in the space provided.
4. A photo of the fish and entrant shall be submitted along with the score sheet, if at all possible.
5. NCBA members must turn score sheets into the Records Chairman by the announced cutoff date each year, usually in January, to qualify for the "NCBA Annual Contest". There is NO cutoff date for entry into the "All Time Records Listings" and entrants are not required to be NCBA member when fish are harvested.
6. The official score and placement on the "All Time Records" shall be determined by the total weight of the fish, in pounds and ounces. The heaviest entry shall "score", or be "listed" in the highest position.
7. In the event of a tie in weight, the winner shall be determined first by the greater Length. In the event of a tie in Length, then the winner shall be determined second by the greater Girth. In the event that the weight, length, and girth are all exactly the same, then the fish involved shall be declared a "TIE".
8. Any fish taken from a river, stream, lake or other impoundment which has an abnormally low water level due to extreme drought or drainage, whether natural or intentional, shall NOT be eligible for inclusion in the NCBA "All time Records" or "NCBA Annual Awards Contest". The fish must have an avenue of escape.
9. Fish taken from waters where "Reciprocal" agreements with adjacent states exist are eligible for NCBA Annual Contests and the NCBA "All time Records Listings"
